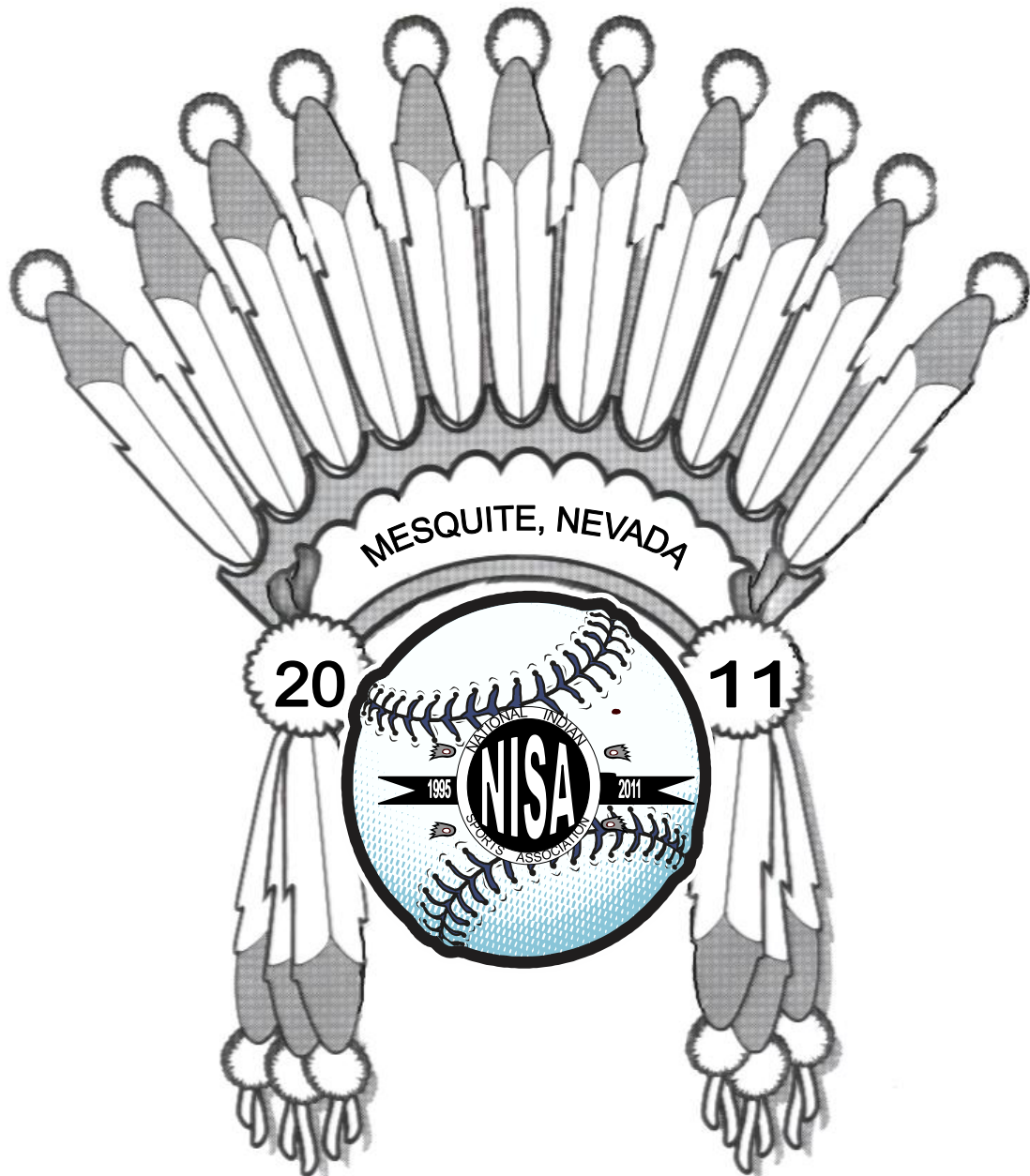

**CONGRATULATIONS!** Your team is invited to enter the **2011 NISA Native American World Series** on **September 23-25**, in **Mesquite, Nevada**. This tournament will be ran in accordance with rules and regulations of the **National Indian Sports Association** and the **Park Policy of the City of Mesquite**.

**GOLF TOURNAMENT:** - on September 22 for those interested in Golfing There will be a Native American Golf Tournament – A 2 Person Scramble at \$60.00 each player and you Must show proof of Indian Identification. All golfers must have there entry fee by September 12, 2011.

**NISA Scholarship 5K & Fun Run:** - on September 24 For those interested, we will be holding a 5K and Fun Run. \$15 for adults and Free to children 12 and under. **T-shirt only for those who pre-register.**

**LOCATION: Pioneer Park:** 501 Hillside Drive, Mesquite, Nevada.

**ROSTER:** Your official NISA team **Entry Form**, along with your **Entry Fee MUST** be sent to the **NISA NATIONAL OFFICE**. **All teams must turn in there rosters at the managers meeting.**

**ENTRY FEE: \$400.00 NO REFUNDS WILL BE GIVEN**

**All players must pay a \$2.00 registration fee and check in with their Indian Identification before receiving their player's pass.** (Players can register Thursday Night at the Casa Blanca Hotel in the Kon Tiki Room From 5 to 10.) Your **Entry Fee** should be mailed by **certified check** or **money order** to the **NISA National Headquarters** along with your roster, and the attached entry form, **to arrive in our office** no later than **September 12th** (Entries that arrive in our office after the 12th will be subject to the late fee - So mail out early.) **(Late entries will be required to pay an additional fee of \$50.00 per week. We cannot except entries After the 17<sup>th</sup>!) No Exceptions our office will be closed so we can travel to Mesquite also!**

**CONDITIONS:** The Tournament Committee reserves the right to rule on matters as they occur, including any deemed necessary to complete the tournament. The committee assumes that all players are competing at their own risk and will not be liable for any accidents or injuries. Entry into this tournament constitutes agreement to these conditions.

**MANAGER'S MEETING: Thursday, September 22nd, starting promptly at 8:00 p.m., all teams must have a representative present to receive their tournament packets and official game times. The official tournament bracket will be done at this time. Failure to attend this meeting will not be an acceptable excuse for not having the most updated information. Seating will be limited to **Only ONE (1)** representative from each team entered in the tournament. Meeting will be held in the Lava Room at the Host Hotel Casa Blanca - 950 W. Mesquite Blvd, NV 89027**

**GAME SCHEDULES:** Game times will be announced in the managers meeting. All teams must be Prepared to play on **Friday September 23rd 2011. Please do not enter the tournament if you cannot play on Friday.** First round games may not be played in numerical order since consideration may be given to teams traveling the greatest distance. No grace period will be allowed unless deemed necessary by the tournament committee due to an emergency.

**TOURNAMENT RULES:**

- 1) Teams **MUST** be prepared to play 30 min. prior to scheduled game time.
- 2) Lineups are due 15 min. prior to game time.
- 3) All Players **MUST** carry **Picture ID, current drivers license, and Indian Identification with them at all times.**
- 4) All protest will require a \$150.00 fee. Before the next pitch.
- 5) All Indian rosters are allowed 2 non-Native American players **(Coed is 1 Female & 1 Male)**
- 6) 1 Coach per team, all coaches must wear uniform like team and must stay in dugout, **No Kids in Dugouts**

**UNIFORMS:** All players must wear matching shirts with numbers. Shorts, pants and hats are optional, but must be alike if worn. **NO METAL CLEATS** will be allowed.

**Uniforms are not protestable**, however, if one team has matching shirts with numbers and the other team does not, the team with matching shirts with numbers has the option to be home team.

**SOUVENIRS:** A wide variety of souvenir items will be available for purchase each day during the tournament and at the manager's meeting. We urge you to select your souvenirs early, as we sell out early every year.

By completing this event registration, both you and NISA agree that the statutes and laws of the State of Utah, without regard to the conflict of laws principles thereof, will apply to all matters relating to this event registration, this Agreement and Waiver.
